### **1. Call to Order**

Mayor Ken Rethmeier called the meeting to order.

### **2. Adoption of the Agenda**

*Council Member Ed Coley made the motion to adopt the agenda, and Council Member Jerry West seconded the motion. The motion was approved by a vote of five (5) in favor and none opposed.*

### **3. Approval of the October 25, 2016 Agenda Meeting Minutes**

*Council Member Shirley Cagle made a motion to approve the minutes from the October 25, 2016 Agenda Meeting. Council Member John Guglielmi seconded the motion. The motion was approved by a vote of five (5) in favor and none opposed.*

### **5. Items for Consideration**

#### **A. Presentation of 2015-2016 Town Audit**

Tony Brewer with Eddie Carrick, CPA provided an overview of the Town audit. The audit book is public record and available at Town Hall. He began his review by thanking the Town Council for allowing their group to be the Town's auditors for another year, then reviewed the highlights of the audit.

#### **B. Projected Startup Costs for Minimum Police Department Staffing**

Lee Rollins, Town Manager presented his findings for startup costs to establish a Police Department in the Town. The minimum would be a staff of 5 people to run a 24/7 department and the bare minimum cost would be around \$557,000. Brian Williams, Attorney discussed legal costs that could also be associated, saying it's impossible to put an exact cost to having a Police Department.

*Council Member Jerry West made a motion to "put this subject to bed", and to also discuss other options (educating residents/ community watch) at the January Planning Session. Council Member Ed Coley seconded the motion. The motion was approved by a vote of five (5) in favor and none opposed.*

#### **C. TIP Project No. I-0911 A (Widening of 1-40)**

Lee Rollins provided aesthetic designs for noise walls (that can only be installed during widening projects by DOT), and design options for a pedestrian bridge.


**7. Town Manager Comments**

**8. Adjourn**


