# **Town Council Meeting Minutes**

September 10, 2019 – 6:00 PM

The Town Council of Bermuda Run held its scheduled meeting on Tuesday, September 10, 2019 at 6:00 PM. The meeting was held at Bermuda Run Town Hall.

<u>Call to Order</u> Mayor John Guglielmi called the meeting to order.

### Pledge of Allegiance

#### **Moment of Silence**

It is the intent of the Town Council to solemnize the proceedings of this meeting and the business brought before the governing board, to offer the opportunity for a reflective moment of silence.

### Adoption of the Agenda

Town Manager, Lee Rollins clarified that there will be no Public Hearing tonight on the Zoning Map Amendment, and noted that the corrected August Minutes were provided by the Town Clerk for approval. Council Member Rick Cross made a motion to approve the agenda as amended. Council Member Jerry West seconded the motion. The motion was approved by a vote of three (3) in favor and none opposed.

### Approval of the August 13, 2019 Town Council Meeting Minutes

Council Member Jerry West made a motion to approve the August 13 Meeting Minutes. Council Member Rick Cross seconded the motion. The motion was approved by a vote of three (3) in favor and none opposed.

### **Public Comments - NONE**

#### **Zoning Map Amendment 2019-03**

The applicant Bob Hodges requests a rezoning from RM Residential Mixed to CM Commercial Mixed in order to develop the property commercially. The site is 2.55 acres. This is an expansion of the CM zoning district located on three sides of the site (see zoning map). A Public Hearing on the issue was conducted at the August 13, 2019 Town Council Meeting.

Council Member Rick Cross made a motion for approval of the amendment — "The Town Council finds that the proposed general use rezoning is consistent with the Town of Bermuda Run Comprehensive Plan, specifically the objective to utilize the future land use map to encourage managed growth that is compatible with the Town's character, surrounding land uses, available infrastructure, services, and considers the action to be reasonable and in the public interest." Council Member Jerry West seconded the motion. The motion was approved by a vote of three (3) in favor and none opposed.

### Bermuda Run West Common Area Maintenance Contract

Bermuda Run West HOA is going under contract with Chamberlain Landscaping and Lawn Care for annual maintenance starting January 1, 2020. The landscaped street islands with postal kiosks are maintained by the Town. Since the August 27 Agenda Meeting, the cost per month has been reduced by \$30 to reflect no Fall reseeding.

Council Member Mike Ernst made a motion to approve the contract with Chamberlain with Council Member Jerry West seconding the motion. The motion was approved unanimously.

## Recommendation of Award - Yadkin Valley Sidewalk Project

Bids were invited and received by 2:00 pm on August 27, 2019. The lowest responsible bids totaled \$197,403 for the project. Council Member Rick Cross questioned the timing on the project which should be in the next 30 days.

Council Member Jerry West made a motion to award general construction portion of the project to Fuller Contracting, LLC and signal modification to Fulcher Electric for a total contract price of \$197,403. Council Member Rick Cross seconded the motion. The motion was approved by a vote of three (3) in favor and none opposed.

Council Member Rick Cross made a motion to approve the budget amendment to the General Fund to allocate \$197,403 from General Fund balance to pay for the project contract price of \$197,403. Council Member Mike Ernst seconded the motion. The motion was approved by a vote of three (3) in favor and none opposed.

### 2019 Proclamation - National Senior Center Month

The Town Council officially recognizes the special contribution of the senior center participants and special efforts of the staff and volunteers who work every day to enhance the well-being of the older citizens of our community.

Council Member Jerry West made a motion to proclaim September as "National Senior Center Month", with Council Member Mike Ernst seconding the motion. The motion was approved by a vote of three (3) in favor and none opposed.

#### **Council/ Mayor Comments**

Jerry West – Feels that the Council is off to a good start with John Guglielmi as Mayor. Mike Ernst and Rick Cross – Congratulated John Guglielmi and shared positive feedback from the Ultimate Eagles Tribute Band concert.

Mayor John Guglielmi – Thanked everyone for the opportunity to serve as Mayor for a short time, saying he was honored.

#### Town Manager

Lee Rollins thanked the Council for their willingness and candor, saying he's been honored to serve for the past 10 years.

### Adjourn

With no further business to discuss, Council Member Mike Ernst made a motion to adjourn. Council Member Jerry West seconded the motion. The motion was approved by a vote of three (3) in favor and none opposed.

**Tourism Development Authority** 

The Town of Bermuda Run Tourism Development Authority was established with approval from the North Carolina General Assembly on December 1, 2010, for the purpose of advertising and promoting tourism.

The Tourism Development Authority shall consist of up to three (3) but no more than seven (7) members, appointed by the Town Council. At least one third of the members of the Authority must be individuals who are affiliated with businesses that collect the occupancy tax levied by the Town. At least one half of the members of the Authority must be individuals who are then currently active in the promotion of travel and tourism in the Town.

The current members of the Authority are:

Scott Wollaston, Executive Director of NC Fusion Wayne Thomas, President of Sterling Events and Owner of WinMock Thomas Shapard, General Manager of the Hampton Inn at Bermuda Run

Ex-officio members are:

Lee Rollins, Town Manager/Finance Director Town of Bermuda Run Caroline Moser, President of the Davie County Chamber of Commerce.

The Authority recommends for Town Council consideration, the appointment of Susan Barrette to the Authority board. Susan is the new Director of Sales and Marketing at the Hampton Inn at Bermuda Run. The individual in her previous position was also on the Authority board.
