As we gathered at Town Hall, we made certain to ensure the safety of all who gathered by strictly adhering to the CDC social-distancing guidelines.

Among the items before the Council was an initial review of our Town Manager's proposed 2020-2021 budget for the Town of Bermuda Run. After reviewing the budget proposal, the Town Council voted to schedule a Public Hearing, to provide for public comment, during the upcoming June 9 Town Council Meeting. Additionally, and in light of our current limitations on gatherings, the Council reviewed a proposed ordinance to allow Town Council Meetings to be conducted remotely (electronically) in certain extraordinary circumstances when gathering in person is impractical or not allowed. The Council will take final action on this recommendation during our upcoming May 12 Town Council Meeting.

As we approach May 8, which is the end of the state's current stay at home order, we will keep you informed of things that may affect our community. The Governor has expressed optimism about the impact of our collective efforts to stay at home and maintain social distancing. He announced hopes to next week move into phase one of his three phase plan to reopen the state if the trends we're seeing are stable enough. We will continue to work with our state and county leaders for the safety and well-being of our citizens as we look ahead.
